

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION  
TO THE HONORABLE GADDI VASQUEZ:

Pursuant to Section 11020, California Elections Code, the undersigned, registered qualified voters of the third Supervisorial District of Orange County, State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Supervisor of the Third District in Orange County, California, and to demand election of a successor in that office.

The grounds for the proposed recall are as follows:

STRIKE ONE: As a supervisor you did not publicly oppose the activities of former Treasurer Bob Citron, which activities led to the loss of \$1.7 billion of taxpayer money, even after John Moorlach had publicly warned about these activities' risks;

STRIKE TWO: You recently supported the Measure R tax increase, after you had told the Committees of Correspondence in writing that you did not intend to seek new taxes as a means to solve the County's fiscal problems;

STRIKE THREE: Last February you voted in closed session to have the County agree to pay around \$1.4 billion in claims by the local agencies which invested in the Pool, rather than vote to litigate against these claims, and this action has created severe pressures for a tax increase.

"THREE STRIKES, YOU'RE OUT!!"

The Recalled officer may file an answer.

(a) Within seven days after the filing of the notice of intention, the officer sought to be recalled may file with the clerk, or in the case of a state officer, the Secretary of State, an answer, in not more than 200 words, to the statement of the proponents.

(b) If an answer is filed, the officer shall, within seven day after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention.

(c) The answer shall be signed and shall be accompanied by the printed name and business or residence address of the officer sought to be recalled.
